- Two Payment Gateway is available. 1. CC Avenue and 2. Atom. Default Payment Gateway is CC Avenue. Click on "Pay Online" button for making fee payment through "Net Banking, Credit / Debit Card, UPI".
- 7. After making fee payment take a screenshot of the fee payment advice and get Fee Receipt from College Office. Obtaining Fee Receipt from College Office is compulsory for every student.
